INVITATION TO BID NO. 2020-06-46A
Procurement of one (1) lot Laboratory Examinations and Diagnostic
Procedures Send Out for 2020

1. The *City Government of Manila*, through the General Fund CY 2020 – *Other Maintenance and Operating Expenses* intends to apply the sum of *Four Million Eight Hundred Thousand Pesos Only (Php4,800,000.00)* being the Approved Budget for the Contract (ABC) to payment under the contract for the procurement of one (1) lot Laboratory Examinations and Diagnostic Procedures Send Out for 2020 / ITB No. 2020-06-46A. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Manila* now invites Bids from eligible Bidders for the procurement one (1) lot Laboratory Examinations and Diagnostic Procedures Send Out for 2020 for Ospital Ng Maynila Medical Center. Delivery of Goods is within **six (6) months**. Bidders should have completed, at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least twenty five percent (25%) of the Approved Budget for the Contract (ABC). The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act” and is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from *City Government of Manila* and inspect the Bidding Documents at the address given below during *8:00 A.M. to 5:00 P.M.*.
5. A complete set of Bidding Documents may be purchased by interested Bidders on *June 11, 2020* from the address below *and upon payment of non-refundable fee in the amount of Five Thousand Pesos (Php5,000.00)*
6. The *City Government of Manila* will hold a Pre-Bid Conference on *June 19, 2020, 2:00 P.M.* at *City General Services Office ,4th Floor Rm. 442, Manila City Hall Building, A.J. Villegas St., Ermita, Manila*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat, *City General Services Office ,4th Floor Rm. 442, Manila City Hall Building, A.J. Villegas St., Ermita, Manila*, on or before *July 1, 2020, 1:00 P.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *July 1, 2020, 2:00 P.M.*, *City General Services Office ,4th Floor Rm. 442, Manila City Hall Building, A.J. Villegas St., Ermita, Manila*. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The City Government of Manila reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
