WHEREAS, the City Council of Manila passed Ordinance No. 8629, authorizing Supplemental Budget No. 3. Series of 2020, the appropriation of Bayanihan Grant to the City of Manila on the 17<sup>th</sup> of April 2020;

WHEREAS, in order to eliminate the threat of COVID 19, the Office of the Mayor-Public Employment Service Office requested for the procurement of 600,000 pcs. Patch with City of Manila logo based on approved Purchase Request (PR) No. 39 in the total amount of SIX MILLION SIXTY THOUSAND PESOS (Php6,060,000.00) chargeable against Trust Liabilities-Grants and Donations for NCOV19.

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.2 of the 2016 Revised IRR authorizes the conduct of Negotiated Procurement for Emergency Cases under the following circumstances;

- i. In case of imminent danger to life during a state of calamity due to NCOV 19; or
- ii. When time is of the essence arising from natural or man-made calamities; or
- iii. Other causes where immediate action is necessary;
  - a. To prevent damage to or loss of life;
  - b. To restore vital public services, hospitals, infrastructure facilities, and other public utilities;

WHEREAS, in response to the request for quotation only one (1) eligible contractor / supplier **NML & E WORLDWIDE FASHION INC.** submitted price quotation;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of **NML & E WORLDWIDE FASHION INC.** emerged as the Single Calculated Bidder, the result of which is as follows:
