**RESOLUTION NO. 20 - INFR-11**

WHEREAS, the **REDEVELOPMENT OF MANILA ZOO** located at **M. Adriatico St., Malate, Manila** is one of the priority projects of the City Government chargeable against **Capital Outlay-Other Infrastructure Assets-CY 2019, Department of Engineering & Public Works**.

WHEREAS, the Bids and Awards Committee invited registered contractors to participate in the public bidding through postings at the Website and PHILGEPS and at the conspicuous places of the City Hall premises from June 04 -10, 2020.

WHEREAS, three (3) contractors responded and procured bid documents;

WHEREAS, the public bidding for the project was held on June 23, 2020 at the Conference Room, City General Services Office, Fourth Floor, Manila City Hall Bldg., and the three (3) eligible bidders submitted proposals as follows:

WHEREAS, in the evaluation made by the Technical Working Group and reviewed by the BAC, the bid offer of the lowest bidder, **A.M. ORETA & CO., INC.** in the amount of **Php 1,698,000,000.00** is **2.21%** lower than the **Approved Budget for the Contract**.

WHEREAS, the Technical Working Group, after applying arithmetical check, found no error in the computation of the bill of quantities of the lowest calculated responsive bidder and that all its documents were complying;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **A.M. ORETA & CO., INC.**, its bid has been found to be the lowest and most responsive.

WHEREAS, **A.M. ORETA & CO., INC.** has the financial capability and technical expertise to undertake the project;


NOW, THEREFORE, be it resolved as it hereby resolved, to declare, to proclaim and to recommend the award of the project to **A.M. ORETA & CO., INC.** at the bid amount of **ONE BILLION SIX HUNDRED NINETY EIGHT MILLION PESOS (Php 1,698,000,000.00) ONLY** and require the contractor to post a performance security in accordance with Section 39.2 Revised Implementing Rules and Regulations (IRR) of RA 9184.
