

**RESOLUTION DECLARING THE LOWEST CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF VARIOUS GROCERIES AND RICE FOR DISASTER RELIEF OPERATION AND SLUM CLEARANCE FOR THE PERIOD OF JANUARY TO DECEMBER 31, 2021**

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila December 21, 2020 to January 12, 2021;

WHEREAS, in response with the said advertisements, there are two (2) prospective bidders, **BUGSY BEE GENERAL MERCHANDISE** and **DIAMONDSPHERE, INC.**, which purchased bid documents and submitted their respective bid proposals for the above-mentioned project during the bidding conducted on January 12, 2021 at 4:20 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of Various Groceries and Rice for Disaster Relief Operations and Slum Clearance for the period of January to December 31, 2021 for the Department of Social Welfare is **THIRTY SEVEN MILLION FIVE HUNDRED THOUSAND PESOS ONLY (PHP37,500,000.00)**;

WHEREAS, during the opening of bids, both bidders, **BUGSY BEE GENERAL MERCHANDISE** and **DIAMONDSPHERE, INC.**, passed the preliminary examination of bids and their bid proposals were found to be substantially complying;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the **BUGSY BEE GENERAL MERCHANDISE**, its bid has been found to be the lowest calculated and most responsive;

WHEREAS, BOTH PARTIES agree on partial billing arrangement based on actual deliveries. Partial payment of the Various Groceries and Rice already supplied in accordance with the Terms of Reference shall be allowed subject to accounting rules and regulations;

NOW THEREFORE, the members of the Bids and Awards Committee, RESOLVE as it is hereby RESOLVED:

for the Procurement of Various Groceries and Rice for Disaster Relief Operations and Slum Clearance for the period of January to December 31, 2021 for the Department of Social Welfare;

- b. To proclaim **BUGSY BEE GENERAL MERCHANDISE** as the Lowest Calculated and Most Responsive Bidder for the Procurement of Various Groceries and Rice for Disaster Relief Operations and Slum Clearance for the period of January to December 31, 2021 for the Department of Social Welfare in the total amount of **THIRTY MILLION FIVE HUNDRED FIFTY FOUR THOUSAND FIVE HUNDRED TWENTY PESOS ONLY (PHP30,554,520.00)**; and
- c. To recommend for the approval by the City Mayor of the City Government of Manila as the Head of the Procuring Entity the awarding of the Purchase Order/Contract based on the above premises.


