



**RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF TWO (2) UNITS VEHICLES**

**WHEREAS**, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila from December 29, 2020 to January 19, 2021;

**WHEREAS**, in response with the said advertisements, there is only one (1) prospective bidder, **UNITED ASIA AUTOMOTIVE GROUP, INC.**, which purchased bid documents and submitted its respective bid proposal for the above-mentioned project during the bidding conducted on January 19, 2021 at 3:30 p.m.;

**WHEREAS**, the Approved Budget for the Contract (ABC) for the Procurement of two (2) units Vehicles for the Department of Social Welfare is **THREE MILLION ONE HUNDRED THIRTY-TWO THOUSAND THREE HUNDRED PESOS ONLY (PHP3,132,300.00)**;

**WHEREAS**, during the opening of bids, only one bidder, **UNITED ASIA AUTOMOTIVE GROUP, INC.**, passed the preliminary examination of bids and its bid proposal was found to be substantially complying:

- b. To proclaim **UNITED ASIA AUTOMOTIVE GROUP, INC.** as the Single Calculated and Responsive Bidder for the **Procurement of two (2) units Vehicles for the Department of**



**Social Welfare** in the total amount of **TWO MILLION ONE HUNDRED THIRTY THOUSAND PESOS ONLY (PHP2,130,000.00)**; and

- c. To recommend for the approval by the City Mayor of the City Government of Manila as the Head of the Procuring Entity the awarding of the Purchase Order/Contract based on the above premises
