**RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF ASPHALT, BITUMUL AND THERMOPLASTIC LANE MARKING FOR 2021**

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila from January 21 to February 10, 2021;

WHEREAS, in response with the said advertisements, there is only one bidder, **JASMIG CONSTRUCTION CORPORATION**, which purchased bid documents and submitted its respective bid proposal for the above-mentioned project during the bidding conducted on February 10, 2021 at 2:00 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of Asphalt, Bitumul and Thermoplastic Lane Marking for 2021 for the Department of Engineering and Public Works is **ONE HUNDRED EIGHTEEN MILLION ONE HUNDRED THIRTY SIX THOUSAND SEVEN HUNDRED EIGHTEEN PESOS ONLY (PHP118,136,718.00)**;

WHEREAS, during the opening of bids, **JASMIG CONSTRUCTION CORPORATION**, passed the preliminary examination of bids and its bid proposal was found to be substantially complying:

To declare the bid of **JASMIG CONSTRUCTION CORPORATION** with business address at 9007 bk National Highway, Alangilan, Batangas City, Batangas as the most responsive and single calculated bid for the supply and delivery of Asphalt, Bitumul and Thermoplastic Lane Marking for 2021 for the Department of Engineering and Public Works;
- b. To proclaim **JASMIG CONSTRUCTION CORPORATION** as the Single Calculated and Responsive Bidder for the **Procurement of Asphalt, Bitumul and Thermoplastic Lane Marking for 2021 for the Department of Engineering and Public Works** in the total amount


