

RESOLUTION NO. 2020-735

WHEREAS, City Budget Office, based on its approved Annual Procurement Plan (APP) and Purchase Request (PR) No. 1740, requested for the procurement of various office supplies in the total amount of Sixty Six Thousand Three Hundred Thirty Eight Pesos and 20/100 (Php66,338.20) chargeable against Office Supplies Expenses;

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, the requested various office supplies fall under Shopping of Section 52.1 (b) of the Revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184, otherwise known as Philippine Government Procurement Reform Act (GPRA) and the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR;

WHEREAS, the City Government of Manila posted the Request for Price Quotation in the Philippine Government Electronic Procurement System (PhilGEPS) Website, Website of the City of Manila, and in Bulletin Boards located at various conspicuous places in the Manila City Hall Building from November 27 – December 2, 2020;

WHEREAS, in response to the said postings, three (3) eligible contractors / suppliers namely, BELLWETHER PACKAGING SUPPLIES TRADING, MLJPO ENTERPRISES, and BUGSY BEE GENERAL MERCHANDISE submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of BELLWETHER PACKAGING SUPPLIES TRADING emerged as the Lowest Calculated Bid, the results of which are as follows:
