



RESOLUTION NO. 2020-239

WHEREAS, Urban Settlements Office, based on its approved Purchase Request (PR) No. 82, requested for the procurement of various equipment, supplies and materials in the total amount of One Million Pesos (Php1,000,000.00) chargeable against Resettlement Governance Assistance Fund (RGAF);

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.9 of the 2016 Revised IRR authorizes the conduct of Small Value Procurement, allowing direct negotiation of contracts with suppliers found to be technically, legally, and financially capable of supplying the required goods, provided that, the amount involved does not exceed the threshold prescribed in Annex H of the 2016 Revised IRR and does not fall under shopping in Section 52 of the same implementing rules;

WHEREAS, the City Government of Manila posted the Request for Price Quotation in the Philippine Government Electronic Procurement System (PhilGEPS) Website, Website of the City of Manila, and in Bulletin Boards located at various conspicuous places in the Manila City Hall Building from December 15 - 21, 2020;

WHEREAS, in response to the said postings, three (3) eligible contractors / suppliers namely, MMLS ENTERPRISES, BUGSY BEE GENERAL MERCHANDISE and FULLMAN ENTERPRISES submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of MMLS ENTERPRISES emerged as the Lowest Calculated Bid, the results of which are as follows:


WHEREAS, upon careful examination, validation, and verification of all the technical and financial requirements submitted by MMLS ENTERPRISES, its offer was found to be responsive;






