

RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF 40,000 FOOD PACKS

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila February 18, 2021 to March 10, 2021;

WHEREAS, in response with the said advertisements, there is only one bidder, **ACTIVOS DEVELOPMENT HOLDINGS INC.**, which purchased bid documents and submitted its bid proposal for the above-mentioned project during the bidding conducted on March 10, 2021 at 3:30 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of 40,000 Food Packs for the Department of Social Welfare is **TWENTY MILLION PESOS ONLY (PHP20,000,000.00)**;

WHEREAS, during the opening of bids, **ACTIVOS DEVELOPMENT HOLDINGS INC.**, passed the preliminary examination of bids and its bid proposal was found to be substantially complying:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the **ACTIVOS DEVELOPMENT HOLDINGS INC.**, its bid has been found to be the single calculated and most responsive;

NOW THEREFORE, the members of the Bids and Awards Committee, **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the bid of **ACTIVOS DEVELOPMENT HOLDINGS INC.** with business address at 25 Calvary Hills Damayang Lagi 4, Quezon City as the most responsive and single calculated bid for the Procurement of 40,000 Food Packs for the Department of Social Welfare;
- b. To proclaim **ACTIVOS DEVELOPMENT HOLDINGS INC.** as the Single Calculated and Responsive Bidder for the Procurement of 40,000 Food Packs for the Department of Social


Welfare in the total amount of NINETEEN MILLION NINE HUNDRED SIXTY THOUSAND PESOS ONLY (PHP19,960,000.00); and

- c. To recommend for the approval by the City Mayor of the City Government of Manila as the Head of the Procuring Entity the awarding of the Purchase Order/Contract based on the above premises.


