

RESOLUTION DECLARING THE LOWEST CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF JANITORIAL SERVICES FOR THE FIVE (5) CITY HOSPITALS AND CGSO-MANILA CITY HALL BUILDING INCLUDING ITS SURROUNDING FOR THE PERIOD OF FEBRUARY TO DECEMBER 31, 2021

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila December 21, 2020 to January 12, 2021;

WHEREAS, in response with the said advertisements, there are two (2) prospective bidders, **ALERT GENERAL SERVICES CORPORATION** and **PRIMESEARCH SERVICE PROVIDER CORPORATION**, which purchased bid documents and submitted their respective bid proposals for the above-mentioned project during the bidding conducted on January 12, 2021 at 2:40 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of Janitorial Services for the Five (5) City Hospitals and CGSO-Manila City Hall Building including its surroundings for the period of February to December 31, 2021 for the Ospital ng Maynila Medical Center, Gat Andres Bonifacio Memorial Medical Center, Justice Jose Abad Santos General Hospital, Sta. Ana Hospital, Ospital ng Sampaloc and CGSO-Manila City Hall Building is **SIXTY THREE MILLION ONE HUNDRED SEVENTY SIX THOUSAND NINE HUNDRED THIRTEEN PESOS ONLY (PHP63,176,913.00)**;

WHEREAS, during the opening of bids, both bidders, **ALERT GENERAL SERVICES CORPORATION** and **PRIMESEARCH SERVICE PROVIDER CORPORATION**, passed the preliminary examination of bids and their bid proposals were found to be substantially complying:
