



**RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE RENTAL OF ONE (1) LOT HYBRID ASSISTIVE LIMB FOR THE PERIOD OF APRIL TO DECEMBER 31, 2021**

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila from February 23 to March 15, 2021;

WHEREAS, in response with the said advertisements, there is only one bidder, **NUIT BLANCHE INTERNATIONAL TRADING CORP.**, which purchased bid documents and submitted its bid proposal for the above-mentioned project during the bidding conducted on March 15, 2021 at 2:20 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Rental of One (1) Lot Hybrid Assistive Limb for the period of April to December 31, 2021 for Ospital ng Maynila Medical Center is **EIGHTEEN MILLION SIX HUNDRED THIRTY THOUSAND PESOS ONLY (PHP18,630,000.00)**;






