RESOLUTION RECOMMENDING THE AWARD OF PUBLICATION / MEDIA SERVICES FOR  
THE NEWSPAPER ADVERTISEMENT OF NOTICES TO THE PUBLIC OF THE CITY  
GOVERNMENT OF MANILA UNDER NEGOTIATED PROCUREMENT THROUGH SCIENTIFIC,  
SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES

**WHEREAS**, the City of Manila seek to engage in the publication / media service of the Newspaper Advertisement for Notices to the Public on the disposal of unserviceable properties and auction of patrimonial properties to comply with Commission on Audit (COA) Circular No. 92-386 with an Approved Budget for the Contract (ABC) of FIVE HUNDRED THOUSAND PESOS (Php500,000.00) chargeable against Advertising Expenses;

**WHEREAS**, the City of Manila procured, implemented and selected a creative publication company that caters to newspaper on national circulation with experience knowledge and expertise in delivering the required service through Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services Modality in accordance with the provisions of Republic Act No. 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;


**WHEREAS**, the City of Manila the negotiation with said publication provider who is technically, legally and financially capable based on terms of reference prepared by the end-user;
