

RESOLUTION NO. 2021-56

WHEREAS, the Urban Settlements Office of the City of Manila, based on its approved Purchase Request (PR) No. 289 and per approved Annual Procurement Plan (APP) requested for the rental of four (4) units photocopying machine for three (3) months in the total amount of Thirty Seven Thousand Five Hundred Pesos (Php37,500.00) chargeable against Rent Expenses;

WHEREAS, Section 48.1, Rule XVI, of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that, in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.9 of the 2016 Revised IRR authorizes the conduct of Small Value Procurement, allowing direct negotiation of contracts with suppliers found to be technically, legally, and financially capable of supplying the required goods, provided that, the amount involved does not exceed the threshold prescribed in Annex H of the 2016 Revised IRR and does not fall under shopping in Section 52 of the same implementing rules;

WHEREAS, pursuant to the above provisions and the guidelines prescribed in Annex H of the 2016 Revised IRR, three (3) eligible contractors/ suppliers namely: COPIERONLINE PHILIPPINES INC., PHOTOPRO TRADING & GENERAL MDSE. CO. and CORON ENTERPRISE submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation/offer, the bid of COPIERONLINE PHILIPPINES INC. emerged as the Lowest Calculated Bid, the results of which are as follows:
