**RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL  
AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF BIRTHDAY CAKES FOR  
THE PERIOD OF JANUARY TO JUNE 30, 2021**

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila December 28, 2020 to January 20, 2021;

WHEREAS, in response with the said advertisements, there is one (1) prospective bidder, **LIBERTY FOOD MART, INC.**, which purchased bid documents and submitted its bid proposal for the above-mentioned project during the bidding conducted on January 20, 2021 at 3:10 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of Birthday Cakes for the period of January to June 30, 2021 for the Office of the Mayor – Office of the Senior Citizens' Affairs is **THIRTY FIVE MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS ONLY (PHP35,750,000.00)**;

WHEREAS, during the opening of bids, only bidder, **LIBERTY FOOD MART, INC.**, passed the preliminary examination of bids and their bid proposals were found to be substantially complying:

WHEREAS, BOTH PARTIES, agree on partial billing arrangement based on actual deliveries. Partial payment of Birthday Cakes already supplied in accordance with the Terms of Reference shall be allowed subject to accounting rules and regulations;

NOW THEREFORE, the members of the Bids and Awards Committee, RESOLVE as it is hereby RESOLVED:

- a. To declare the bid of **LIBERTY FOOD MART, INC.** with business address at 1401 Nicolas Zamora Street, Tondo, Manila as the most responsive and single calculated bid for the supply and delivery of Birthday Cakes for the period of January to June 30, 2021 for the Office of the Mayor – Office of the Senior Citizens' Affairs;
- b. To proclaim **LIBERTY FOOD MART, INC.** as the Single Calculated and Responsive Bidder for the Procurement of Birthday Cakes for the period of January to June 30, 2021 for the Office of the Mayor – Office of the Senior Citizens' Affairs in the total amount of **THIRTY FIVE MILLION SIX HUNDRED FIFTY TWO THOUSAND FIVE HUNDRED PESOS ONLY (PHP35,652,500.00)**; and


