**RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE
PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF ONE (1)
LOT MANILA E-CITIZENS AND E-SERVICES SYSTEM**

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila December 29, 2020 to January 19, 2021;

WHEREAS, in response with the said advertisements, there is one (1) prospective bidder, **MULTISYS TECHNOLOGIES CORPORATION**, which purchased bid documents and submitted its bid proposal for the above-mentioned project during the bidding conducted on January 19, 2021 at 3:40 p.m.;




