**RESOLUTION DECLARING THE LOWEST CALCULATED BID AND RESPONSIVE
PROPOSAL AND RECOMMENDING APPROVAL FOR THE
PROCUREMENT OF ONE (1) UNIT 2D ECHO ULTRASOUND MACHINE**

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila from March 2 to 22, 2021;

WHEREAS, in response with the said advertisements, there are two (2) prospective bidders, **COSMO MEDICAL, INC.** and **INTERNATIONAL DIAMOND ETH, INC.**, which purchased bid documents and submitted their respective bid proposals for the above-mentioned project during the bidding conducted on March 22, 2021 at 2:00 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of One (1) unit 2D Echo Ultrasound Machine for Sta. Ana Hospital is **EIGHT MILLION SEVEN HUNDRED THOUSAND PESOS ONLY (PHP8,700,000.00)**;

WHEREAS, during the opening of bids, both bidders, **COSMO MEDICAL, INC.** and **INTERNATIONAL DIAMOND ETH, INC.**, passed the preliminary examination of bids and their bid proposals were found to be substantially complying:


