WHEREAS, Office of the Mayor, based on its approved Annual Procurement Plan (APP) and Purchase Request (PR) No. 384, requested for the Procurement of various supplies and materials in the total amount of Thirty-Seven Thousand Six Hundred Pesos (Php37,600.00) chargeable against Extraordinary & Miscellaneous Expenses;

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.9 of the 2016 Revised IRR authorizes the conduct of Small Value Procurement, allowing direct negotiation of contracts with suppliers found to be technically, legally, and financially capable of supplying the required goods, provided that, the amount involved does not exceed the threshold prescribed in Annex H of the 2016 Revised IRR and does not fall under shopping in Section 52 of the same implementing rules;

WHEREAS, pursuant to the above provisions and the guidelines prescribed in Annex H of the 2016 Revised IRR, three (3) eligible contractors / suppliers namely, MLJPO Enterprises, Buggy Bee Gen. Mdse. and Z. Latoja Gen. Mdse. submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of MLJPO Enterprises emerged as the Lowest Calculated Bid, the results of which are as follows:


WHEREAS, upon careful examination, validation, and verification of all the technical and financial requirements submitted by MLJPO Enterprises, its offer was found to be responsive;






