



RESOLUTION NO: 2021-147

WHEREAS, Office of the Mayor – PESO Manila, based on its approved Annual Procurement Plan (APP) and Purchase Request (PR) Nos. 1861 & 1862, requested for the Procurement of various office equipment in the total amount of Thirty-Nine Thousand Five Hundred Pesos (Php39,500.00) chargeable against Capital Outlay - Machineries & Equipment Office Equipment, Other Property, Plant and Equipment;

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.9 of the 2016 Revised IRR authorizes the conduct of Small Value Procurement, allowing direct negotiation of contracts with suppliers found to be technically, legally, and financially capable of supplying the required goods, provided that, the amount involved does not exceed the threshold prescribed in Annex H of the 2016 Revised IRR and does not fall under shopping in Section 52 of the same implementing rules;

WHEREAS, pursuant to the above provisions and the guidelines prescribed in Annex H of the 2016 Revised IRR, three (3) eligible contractors / suppliers namely, Z. Latoja Gen. Mdse., Buggy Bee Gen. Mdse. and MLJPO Enterprises submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of Z. Latoja Gen. Mdse. emerged as the Lowest Calculated Bid, the results of which are as follows:
