RESOLUTION NO. EC2021-174

WHEREAS, His Excellency, Rodrigo R. Duterte, President of the Republic of the Philippines thru Proclamation No. 1021 declaring an Extension of State of Calamity under Proclamation No. 929 throughout the Philippines due to Corona Virus Disease 2019 in the City of Manila on September 16, 2020;

WHEREAS, in order to alleviate the needs of the NCOV 19 victims, Ospital ng Sampaloc requested for the procurement of one (1) unit mobile x-ray system based on Purchase Request (PR) No. 029 in the total amount of FOUR MILLION THREE HUNDRED THOUSAND PESOS (Php4,300,000.00) chargeable against Philhealth Trust Fund;

WHEREAS, Section 48.1, Rule XVI, of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.2 of the 2016 Revised IRR authorizes the conduct of Negotiated Procurement for Emergency Cases under the following circumstances:

- i. In case of imminent danger to life during a state of calamity due to NCOV19; or
- ii. When time is of the essence arising from natural or man-made calamities; or
- iii. Other causes where immediate action is necessary:
  - a. To prevent damage to or loss of life
  - b. To restore vital public services, hospitals, infrastructure facilities, and other public utilities;

WHEREAS, in response to the request for quotation, only one (1) eligible contractor/ supplier, DEXTEL TRADING submitted Price Quotation;

WHEREAS, in the detailed evaluation of the quotation/ offer, the bid of DEXTEL TRADING emerged as the Single Calculated Bidder, the result of which is as follows:


WHEREAS, upon careful examination, validation, and verification of all the technical and financial requirements submitted by DEXTEL TRADING, its offer was found to be responsive;


