RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF TWO (2) UNITS PICK-UP TYPE VEHICLES AND ONE (1) UNIT MULTI-PURPOSE VEHICLE

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila from March 30 to April 19, 2021;

WHEREAS, in response with the said advertisements, there is only one bidder, **TOYOTA COMMONWEALTH, INC.**, which purchased bid documents and submitted its respective bid proposal for the above-mentioned project during the bidding conducted on April 19, 2021 at 2:30 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Procurement of 2 units Pick-Up Type Vehicles and One (1) Unit Multi-Purpose Vehicle for the Office of the Mayor is **THREE MILLION FIVE HUNDRED TWENTY NINE THOUSAND PESOS ONLY (PHP3,529,000.00)**;

WHEREAS, during the opening of bids, **TOYOTA COMMONWEALTH, INC.**, passed the preliminary examination of bids and its bid proposal was found to be substantially complying:

NOW THEREFORE, the members of the Bids and Awards Committee, **RESOLVE** as it is hereby **RESOLVED**:




**MILLION FIVE HUNDRED TWENTY SIX THOUSAND THREE PESOS ONLY
