RESOLUTION NO. 2021-159

WHEREAS, Department of Tourism, Culture and Arts of Manila, based on its approved Annual Procurement Plan (APP) and Purchase Request (PR) No. 115, requested for the Procurement of various office supplies in the total amount of One Hundred Twenty Thousand Six Hundred Ninety-Nine Pesos (Php120,699.00) chargeable against Office Supplies Expenses;

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 52, Rule XVI of the 2016 Revised IRR authorizes the conduct of Shopping as a method of procurement where the procuring entity may simply request for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualification, provided, that the amount involved does not exceed the threshold prescribed in Annex "H" of the implementing rules;

WHEREAS, the City Government of Manila posted the Request for Price Quotation in the Philippine Government Electronic Procurement System (PhilGEPS) Website, Website of the City of Manila, and in Bulletin Boards located at various conspicuous places in the Manila City Hall Building from March 26 to 30, 2021;

WHEREAS, in response to the said postings, three (3) eligible contractors / suppliers namely, S. CLYSLY ENTERPRISES INC., Dege Trading and Azeron Trading & Builders submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of S. CLYSLY ENTERPRISES INC. emerged as the Lowest Calculated Bid, the results of which are as follows:




