

RESOLUTION NO. 2021 - 228

WHEREAS, City Personnel Office, based on its approved Annual Procurement Plan (APP) and Purchase Request (PR) No. 827, requested for the procurement of appointment forms in the total amount of Thirty Two Thousand Three Hundred Pesos (Php32,300.00) chargeable against Printing and Publication Expenses;

WHEREAS, Section 48.1, Rule XVI of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 Revised IRR), provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 53.9 of the 2016 Revised IRR authorizes the conduct of Small Value Procurement, allowing direct negotiation of contracts with suppliers found to be technically, legally, and financially capable of supplying the required goods, provided that, the amount involved does not exceed the threshold prescribed in Annex II of the 2016 Revised IRR and does not fall under shopping in Section 52 of the same implementing rules;

WHEREAS, the City Government of Manila invited bonafide eligible contractors/suppliers to submit their price quotations;

WHEREAS, in response to the said invitations, three (3) eligible contractors / suppliers namely KARYMA OPC, BUGSY BEE GENERAL MERCHANDISE, and MLJPO ENTERPRISES submitted their respective price quotations;

WHEREAS, in the detailed evaluation of the quotation / offer, the bid of KARYMA OPC emerged as the Lowest Calculated Bid, the results of which are as follows:

WHEREAS, upon careful examination, validation, and verification of all the technical and financial requirements submitted by KARYMA OPC, its offer was found to be responsive;






