RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RESPONSIVE PROPOSAL AND RECOMMENDING APPROVAL FOR THE PREVENTIVE MAINTENANCE SERVICES FOR VARIOUS MEDICAL AND HOSPITAL EQUIPMENT FOR 2021

WHEREAS, the City Government of Manila, thru its Bids and Awards Committee, advertised the Invitation to Bid for the procurement of the above-mentioned goods in the Philippine Government Electronic Procurement System (PhilGEPS) and in bulletin boards located in conspicuous places within the City of Manila from May 4 - 24, 2021;

WHEREAS, in response with the said advertisements, there is only one bidder, **GLOBAL MEDICAL SOLUTIONS, INC.**, which purchased bid documents and submitted its bid proposal for the above-mentioned project during the bidding conducted on May 24, 2021 at 2:10 p.m.;

WHEREAS, the Approved Budget for the Contract (ABC) for the Preventive Maintenance Services for Various Medical and Hospital Equipment for 2021 for Sta. Ana Hospital (SAH) is **THREE MILLION SIX THOUSAND EIGHT HUNDRED FIFTY EIGHT PESOS ONLY (PHP3,006,858.00)**;

WHEREAS, during the opening of bids, **GLOBAL MEDICAL SOLUTIONS, INC.**, passed the preliminary examination of bids and its bid proposal was found to be substantially complying:

NOW THEREFORE, the members of the Bids and Awards Committee, **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the bid of **GLOBAL MEDICAL SOLUTIONS, INC.** with business address at 3FRTS Building, #14 Ecomonomia Street Bagumbayan 3, Quezon City as the most responsive and single calculated bid for the Preventive Maintenance Services for Various Medical and Hospital Equipment for 2021 for Sta. Ana Hospital (SAH);
- b. To proclaim **GLOBAL MEDICAL SOLUTIONS, INC.** as the Single Calculated and Responsive Bidder for the **Preventive Maintenance Services for Various Medical and**

Hospital Equipment for 2021 in the total amount of **TWO MILLION NINE HUNDRED FOUR THOUSAND TWO HUNDRED PESOS ONLY (P11P2,904,200.00)**; and

- c. To recommend for the approval by the City Mayor of the City Government of Manila as the Head of the Procuring Entity the awarding of the Purchase Order/Contract based on the above premises.






